

What we do

The impacts of climate change are already affecting people, ecosystems and livelihoods everywhere.

Therefore, we need to transition to a low-emissions economy that can sustain future generations. In the coming years, Member States will need to develop National Energy and Climate Plans (NECPs) to show how they plan to meet their 2030 climate and energy commitments.

In collaboration with **national partners** in 5 countries (**Spain, Italy, Poland, Romania and Hungary**) the PlanUp project closely follows the development of NECPs with specific focus in the **building, agriculture** and **transport** sectors to ensure that they are strong and effective tools to decarbonise Europe.

How we do it

- 1** Build capacity of Local Authorities and Civil Society Organisations to engage in the development and implementation of NECPs.
- 2** Ensure dissemination of good practices and promote well designed, climate friendly sectoral policies
- 3** Improve the understanding of economic and social benefits of climate mitigation actions through quantitative modelling tools
